- Q2 Revenue of \$991 million grew 13% quarter-over-quarter and 30% year-over-year, landing near the top end of our outlook<sup>1</sup>
- Revenue per Active Rider of \$49.89 was the second highest on record, up 1% versus Q1'22 and up 12% versus Q2'21
- Active Riders of 19.9 million increased by 12% quarter-over-quarter and 16% year-over-year, representing the highest number of riders since COVID began
- Contribution Margin of 59.6% exceeded our outlook by 360 basis points<sup>2</sup>
- Q2 Adjusted EBITDA of \$79 million exceeded the high end of our outlook by \$59 million<sup>3</sup>
- 2024 Adjusted EBITDA target of \$1 billion with over \$700 million of Free Cash Flow, which is defined as Operating Cash Flow less Capex. We see multiple paths to achieving these milestones driven by expected industry growth and operating leverage. This assumes an industry Bookings CAGR between 2021 and 2024 in the low to mid 20% range<sup>4</sup>

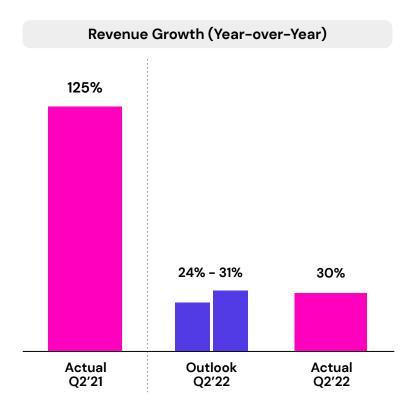

(Year-over-Year)

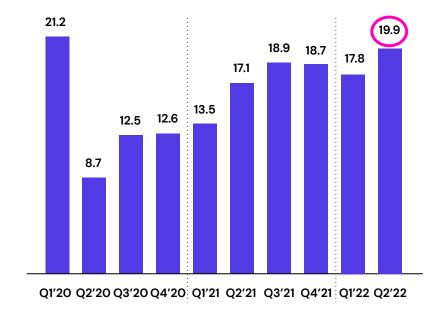

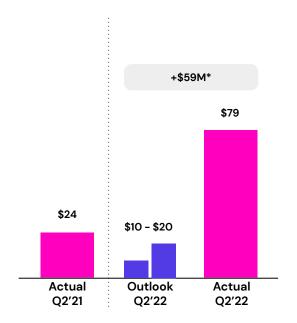
### **Active Riders**

(\$ in millions)

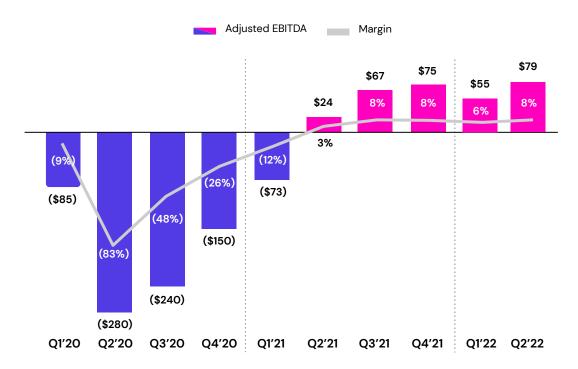

### Adjusted EBITDA & Margin

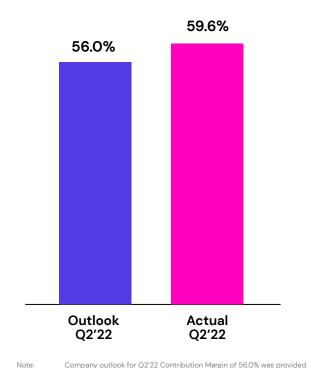

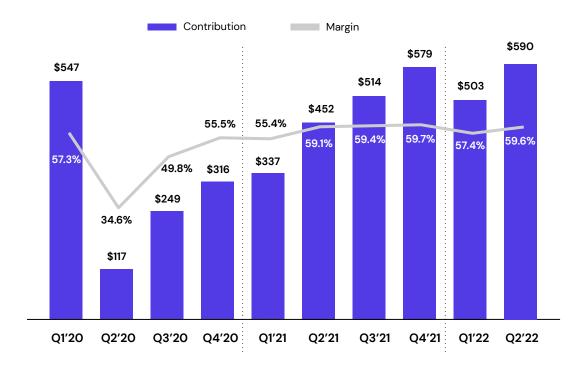
# Contribution Margin Actual vs Outlook
