## **Hilton Grand Vacations Completes \$400 Million Term Note Securitization**

**ORLANDO, Fla. (Dec. 16, 2025)** – [Hilton Grand Vacations Inc.](#) (NYSE:HGV) announces today the completion of a \$400 million securitization of timeshare loans through Hilton Grand Vacations Trust 2025-3EXT (“the Trust”). Four classes of Notes were issued by the Trust, including approximately \$141.2 million of Class A Notes, approximately \$146.6 million of Class B Notes, approximately \$81.4 million of Class C Notes and approximately \$30.7 million of Class D Notes.

The Class A Notes have a coupon rate of 4.56%, the Class B Notes have a coupon rate of 4.90%, the Class C Notes have a coupon rate of 5.39%, and the Class D Notes have a coupon rate of 7.38% for an overall weighted average coupon rate of 5.07%, and an overall advance rate of 96%.

“Completing our fourth transaction of the year and the third under the HGVT platform, marks significant progress towards the optimization of our financing business,” said Dan Mathewes, president and chief financial officer of Hilton Grand Vacations. “The efficient execution, coupled with the continued strong investor engagement, reaffirms the strength of our business and the power of the HGV brand.”

Proceeds of the issuance, net of fees, will be used to pay down debt and for other general corporate purposes.

Deutsche Bank Securities served as the Structuring Lead Manager and Joint Bookrunner along with BofA Securities, Barclays, Wells Fargo Securities and Truist Securities. CIBC Capital Markets, Citizens Capital Markets, Goldman Sachs & Co. LLC, HSBC, MUFG, Regions Securities LLC and R. Seelaus & Co., LLC served as Co-Managers. Alston and Bird LLP represented HGV as issuer counsel.

The Notes were offered in a private placement within the U.S. to persons reasonably believed to be qualified institutional buyers pursuant to Rule 144A under the Securities Act of 1933, as amended (the “Securities Act”) and outside the U.S. to certain non-U.S. persons in accordance with Regulation S under the Securities Act. The Notes have not been registered under the Securities Act or any state securities laws and therefore may not be offered or sold in the United States absent registration or an applicable exemption from the registration requirements of the Securities Act and applicable state securities laws. This press release is an announcement of record only and does not constitute an offer to sell or the solicitation of an offer to buy the Notes, all of which have been sold. Certain classes of the transaction were rated by Fitch Ratings (Fitch) and Moody’s Investors Service, Inc (Moody’s).
