<u>Part II, Box 14 - Describe the organizational action and, if applicable, the date of the action or the date against which shareholders' ownership is measured for the action.</u>

On September 10, 2021, each shareholder of the common stock of DICK'S Sporting Goods, Inc. (the "Company") that was listed as a holder of record became entitled to a cash dividend of \$5.9375 with respect to its common stock. The cash dividend was paid to such shareholders on September 24, 2021. On September 9, 2021 (the "Ex-Dividend Date"), pursuant to the Indenture, dated April 17, 2020, (the "Indenture") by and between the Company and U.S. Bank National Association, as trustee, in connection with the Company's 3.25% Convertible Senior Note due 2025 (the "Notes"), the cash dividend resulted in an adjustment to the conversion rate, effective immediately after 9:00 a.m., New York City time on such Ex-Dividend Date. After giving effect to the adjustment, as of the Ex-Dividend Date, the conversion rate was changed from 29.0422 shares of common stock per \$1,000 principal amount of Notes to 30.3858 shares of common stock per \$1,000 principal amount of Notes.

Part II, Box 15 - Describe the quantitative effect of the organizational action on the basis of the security in the hands of a U.S. taxpayer as an adjustment per share or as a percentage of old basis.

The Company expects the conversion rate adjustment to be treated for U.S. federal income tax purposes as a deemed distribution under Code Section 305(c) as a result of such adjustment compensating the holder for cash distributed to shareholders that are taxable under Code Section 301. The amount of the deemed distribution was calculated to be \$180.4186 per \$1,000 principal amount of Notes as shown below in Part II, Box 16.

The distribution is expected to be made from the earnings and profits of the Company, based on reasonable assumptions currently available. As a result, the dividend of \$180.4186 per \$1,000 principal amount of Notes should increase the holder's tax basis by the amount of the distribution.

<u>Part II, Box 16 - Describe the calculation of the change in basis and the data that supports</u> the calculation, such as the market values of securities and the valuation dates.

Pursuant to the Indenture, the conversion calculation is defined as $A = B^*[C/(C-D)]$, where:

- A = Updated conversion rate = 30.3858
- B = Conversion rate on the date before the Ex-Dividend Date = 29.0422
- C = Closing stock price on the day before the Ex-Dividend Date = \$134.28
- D = Dividend amount per common share = \$5.9375

Using the same variables above, the deemed distribution calculation is defined as (A-B)*C. The deemed distribution amount per \$1,000 principal amount of Notes is \$180.4186.

Tax consequences to holders of the Notes are determined under Code Sections 301, 305(c), 312 and 316 and Treasury Regulations Sections 1.305-3 and 1.305-7.

No holders of the Notes will recognize a loss as a result of the adjustment to the conversion rate of the Notes.

The effective date of the conversion rate change is September 9, 2021. For calendar year taxpayers, the reportable tax year is 2021.
